Important Community Reminders

(Community Handbook, Page 5) **Parking and Vehicular Restrictions** – Owners and guests should adhere to the 15 mph speed limit when driving through the community. Owners are responsible for assuring that their guests abide by the parking restrictions.

(Community Handbook, Pages 7-8) **Garbage Collection** – Garbage containers shall be stored in fenced yards or in garages. All trash cans must be kept out of view and may not be visible from neighboring properties. Garbage containers may be placed outside in view no earlier than 6 p.m. on the day before garbage pickup is scheduled and must be returned to storage area by 11 p.m. same day as scheduled pickup.
